This MEMORANDUM OF UNDERSTANDING (hereinafter referred to as the "MOU") was entered into at Nagercoil on 27<sup>th</sup> March 2025

### BETWEEN

Transorze Information Processing Solutions Pvt Ltd, (operating under the brand name Transorze Solutions) is a Company registered and incorporated under the Companies Act, 2013 having registered office at Rahath Towers, Tc-48/48(2), Bypass Road, Ambalathara Junction, Thiruvananthapuram-26. Represented by its Senior Business Development Manager **Mr.Ranjith NV**, herein after referred to as the "Transorze Solutions" (which expression shall mean and include its successors in title) of the First Party;

**Department of Zoology, Sree Ayyappa College for Women Chunkankadai, Nagercoil,** Tamil Nadu herein after referred to as the "**College**" Represented by Principal : Dr V. R Anjana (which expression shall, unless the context otherwise requires, include his heirs, executors, administrators and assigns) of the **Second Party**,

Transorze Solutions and the College are herein after individually referred to as a "**Party**" and collectively referred to as the "**Parties**".

#### **WHEREAS**

- A. Transorze Solutions provides Career-oriented training in skill development courses viz Digital Marketing, Medical Scribing, Medical Coding, Medical Transcription, Hospital Administration, and OET. Training Partners of National Skill Development Corporation (NSDC) which comes under the Ministry of Skill Development & Entrepreneurship (MSDE). Licensed Education Providers for American Academy of Professional Coders (AAPC) which is an international body responsible for certifications for the Healthcare BPO sector.
- B. Sree Ayyappa College for Women Chunkankadai is a Government Aided institution affiliated with Manonmaniam Sundaranar University, offering programs in Management, Humanities, and Science at UG, PG, and Doctorate levels.

Herein after both parties have intended, agreed, and consented to the following terms and deeds in pursuance of common intent to promote cooperation in education and skills to the MOU witnessed as follows:

### **1. Field of Cooperation:**

Through this MOU, Transorze Solutions Has agreed to the following

- a. Offer an Add-on **Course** viz. "**Medical Coding**"
- b. Provide Certificates to students of the College after the successful completion of the Course.
- c. The **Course** shall be conducted for 200 hours in the agreed period by the MOU.
- d. The Second Party has to give proper communication to the First party regarding commencement of training prior to 20 days to 30 days of time
- e. Financials: Both Parties have agreed to the below:-

- Course Fees:Rs.23,800/-per student (Bajaj EMI)
- No.ofstudents:7





- Training Duration will be three to four months and it will be commenced from the Month of May, June, July and August
- First installment will be collected before commencement of training and second installment will be collected on first week of May 2025
- NSDC certificates will be provided to each student
- Activity cum lesson planner will be finalized by the both parties on a mutual discussion

## 2. Miscellaneous:

- The details for the efficacious implementation of this MOU shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the Parties.
- The Parties to this MOU may, by mutual consent, add, modify, amend, delete, review or revise any term(s) and condition(s) of this MOU.
- This MOU shall be valid for the period of one year from the date of signing and seal by authorized representatives of both Parties. On the expiry of the Term, this MOU shall be at the option of the parties, if the Parties desire to be renewed for further term (as agreed between the Parties) on the terms and conditions as may be mutually agreed by them subject to execution of a fresh MOU.
- Intellectual Property Rights(IPR)
  - All teaching methodology, course content such as (but not limited to) learning material, LMS content, assignments, case studies, and question banks are the sole Intellectual Property of Transorze Solutions.
  - The above are being shared with the college for the sole purpose of training 7 students as mentioned in this MOU.
  - The college shall not replicate or reuse the above for any other purpose or for any other batch without the prior written permission of Transorze Solutions
- Termination
  - This MOU may be terminated by either Party by giving a six months prior notice to the other party and mentioning the reasons, it should be in writing.
  - Any termination pursuant to the above paragraph will not relieve either party of any obligation or liability accrued hereunder prior to such termination.



- Termination of the agreement should be implemented in such a way that the future of the trainees is not affected by the termination, provided the financial obligations of licenses issued are settled in full.
- f. All disputes and differences relating to this MOU, and any other matters related here to or as to the interpretation or enforcement of this MOU shall be subjected to the exclusive jurisdiction of the courts/forums/tribunals in Trivandrum, Kerala
  - g. That all disputes between the parties shall be referred to arbitration by a sole arbitrator appointed by the Parties. The arbitration shall be conducted in accordance with the provisions of the Arbitration and Conciliation Act, 1996 as amended from time to time. The venue of arbitration proceedings shall be Trivandrum, Kerala. The language of arbitration proceedings shall be English.
  - h. If at any time during the term of this MOU the performance in whole or in part of either Party's obligation under this MOU is prevented or delayed by any reason beyond the control of the Parties hereto, including but not limited to fire, storm, flood, earthquake, explosion, accident, military operation, war rebellion, pandemic, riot wreck, epidemic embargo any virus in the system, any other electronic malfunctioning, or any laws, regulations or other governmental actions, neither Party shall be entitled to terminate this MOU nor shall either Party have any claim for damages against the other in respect of such non-performance or delay in performance, and shall be entitled to resume as soon as practicable after any such event has come to an end or ceased to exist.
  - i. This MOU drafted and completed in English is hereby signed in two sets of copies. Each copy is considered as the original and each Parties keep one copy in their possession.
